National Mission for Jobs

6. It was agreed that Local Government is at the heart of this work and there are resources available to input to this process.

Action DB3-04: CoSLA to pass details of their Mission for Jobs point of contact to TS

7. The Board asked TS to consider how softer skills, such as those needed to influence behaviour change, can be taken forward as the paper contains more emphasis on traditional engineering skills.

Action DB3-05: TS to consider how softer skills will be addressed in the National Mission for Jobs work

- 8. TS will consider the Poverty and Inequality report and ten principles of the Child Poverty Action Group when developing this work.
- 9. The work will be welcomed by the business community and education sector and there could be skills development opportunities within free ports and the tourism and hospitality sectors.
- 10. TS will consider holding conversations with the Scottish Funding Council about the transition to green jobs after today's meeting.

Scottish Transport Appraisal Guidance (STAG)

- 11. Improvements are being made to STAG to make it accessible to all, including simplifying and reducing its length. Although there will be technical detail in the document, TS are also working on improving the readability of the document.
- 12. The next Appraisal User Group meeting is scheduled for late September 2021 and feedback on the Managers Guide will be incorporated into the process ahead of publication end of this year.
- 13. Although the first draft of the document is underway, TS will consider how communities are engaged at the end user stage of the process.
- 14. Work has not yet started on the technical database but an Island Communities Impact Assessment will be part of that process.

Second Strategic Transport Projects Review (STPR2)

- 15. TS recognises the challenge of achieving a balance of delivering the vision while ensuring urban and rural issues are addressed and is mindful of this in the appraisal being undertaken in STPR2.
- 16. TS held an engagement session with MSPs. MPs were also contacted following publication of the Phase 1 and National Case for Change reports.

Action DB3-07: TS to share STPR2 slides with Board members.
