The Scottish Ministers make the following Order in exercise of the powers conferred by sections 82(2), 83(1), 84(1)(a) and (c) and 124(1)(d) of, and paragraph 27 of schedule 9 of, the Road Traffic Regulation Act $1984(\mathbf{a})$ and all other powers enabling them to do so.

In accordance with section $84(2)(\mathbf{b})$ of that Act, they have given public notice of their intention to make the following Order, and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(\mathbf{c}).

Citation and commencement

1. This Order may be cited as the A82 Trunk Road (Fort Augustus) (20mph and 30mph Speed Limits) Order 202[] and comes into force on [] 202[]

Speed limits

2. No person may drive any motor vehicle at a speed exceeding—

- (a) 20 miles per hour on the length of road specified in Part 1 of the schedule,
- (b) 30 miles per hour on the length of road specified in Part 2 of the schedule.

Revocation

3. The A82 Trunk Road (Fort Augustus) (Restricted Roads) Order 2000 (d) is revoked.

Exemption

4. No speed restriction imposed by this Order applies to—

SCHEDULE SPECIFIED LENGTHS OF ROAD

Part 1

1. That length of A82 Dalnottar - Inverness Trunk Road at Fort Augustus from a point 83 metres or thereby north east of the centre line of its junction with the U1671 Fort Augustus Old Main Road to a point 52 metres or thereby south of the centre line of its junction with the U1718 Abertarff Place, a distance of 1.268 kilometres or thereby.

Part 2

2. That length of A82 Dalnottar - Inverness Trunk Road at Fort Augustus from a point 52 metres or thereby south of the centreline of its junction with U1718 Abertarff Place to a point 35 metres or thereby south of the centre line of the Fire Station access road, a distance of 400 metres or thereby.
