# THE A83 TRUNK ROAD, (REST AND BE THANKFUL) COMPULSORY PURCHASE ORDER 202[]

Made 202[]

The Roads (Scotland) Act 1984 and the Acquisition of Land (Authorisation Procedure) (Scotland) Act 1947.

The Scottish Ministers (hereinafter referred to as "the acquiring authority") in exercise of the powers conferred by sections 103 to 108 inclusive as read with section 110(2) of the Roads (Scotland) Act 1984 hereby make the following compulsory purchase order—

- 1. This Order may be cited as the A83 Trunk Road, (Rest and be Thankful) Compulsory Purchase Order 202[].
- 2. Subject to the provisions of this Order, the acquiring authority are hereby authorised to purchase compulsorily for the purpose of protecting, and improving the resilience of, the A83 Trunk Road at Rest and Be Thankful, Argyll and Bute, through the provision of a debris flow shelter, road upgrades, junction improvements, constructing landslip protection measures above and below the A83 Trunk Road and by establishing a temporary diversion route for the A83 Trunk Road by improving and widening the Old Military Road, the land described in the Schedule hereto and are delineated in red and coloured pink respectively on the map signed with reference to this Order and marked "Map referred to in the A83 Trunk Road, (Rest and be Thankful) Compulsory Purchase Order 202[]".
- 3. In relation to the foregoing purchase section 70 of the Railways Clauses Consolidation (Scotland) Act 1845 and sections 71 to 78 of that Act as originally enacted and not as amended for certain purposes by section 15 of the Mines (Working Facilities and Support) Act 1923 are hereby incorporated with the enactment under which the said purchase is authorised, subject to the modifications that references in the said sections to the company shall be construed as references to the acquiring authority and references to the railway or works shall be construed as references to the land authorised to be purchased and any buildings or works constructed or to be constructed thereon.

4. For the purpose of the said section 71 of the R (Scotland) Act 1845, as incorporated in this Order, the presesseam of minerals lying under land adjoining the works to described in the Schedule hereto shall be such a lateral distanside thereof as is equal at every point along the said works seam below the natural surface of the ground at that point or is the greater.	eribed distance in relation to any o be constructed upon the land ace from the said works on every s to one half of the depth of the

#### In this Schedule: -
