# The A86 Trunk Road (Spean Bridge) (20mph Speed Limit) Order 202[]

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 84(1)(a) and 124(1)(d) of, and paragraph 27 of schedule 9 of, the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with sections 83(1) and 84(2)(**b**) of that Act, they have given public notice of their intention to make the following Order, and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(**c**).

#### Citation and commencement

1. This Order may be cited as the A86 Trunk Road (Spean Bridge) (20mph Speed Limit) Order 202[] and comes into force on << >>.

#### **Speed limit**

**2.** No person may drive any motor vehicle at a speed exceeding 20 miles per hour on the length of road specified in the schedule.

#### Revocation

- 3. The following are revoked—
  - (a) The A86 Trunk Road (Spean Bridge) (30mph Speed Limit) Order 2002(d).
  - (b) The A86 Trunk Road (Spean Bridge) (30mph Speed Limit) Variation and Spean Bridge Primary School (Part-time 20mph Speed Limit) Order 2006(e).

#### Exemption

- **4.** No speed restriction imposed by this Order applies to—
  - (a) vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations; or
  - (b) vehicles being used in an emergency for coastguard purposes.

## **SCHEDULE**

Article 2

## SPECIFIED LENGTH OF ROAD

That length of the A86 Spean Bridge - Kingussie Trunk Road at Spean Bridge, from its junction with the A82 Dalnottar - Inverness Trunk Road to a point 108 metres or thereby east of the extended centre line of its junction with the U2417 Tirindrish Road, a distance of 586 metres or thereby.
